The Peach Bottom Township **Board of Supervisors** met on **July 3, 2024,** at 7:00 p.m. in the Municipal Office Building. Members present David Gemmill (Chair), Mike Kahl (Vice Chair) and Andrew Jarvis.

Public Comment

Brooke Daneker, owner 1790 Bryansville Road, requested information on current ordinances or possibly enacting an ordinance concerning harvesting trees to protect waterways, flood plains, endangered species of animals, and sediment control among other issues that can arise with this activity. She informed of a property where trash was being burned and the fire company was called 3 times to extinguish it. They have buried trash, stripped topsoil and removed all mature trees.

Supervisor Gemmill informed that DEP, the Zoning Officer, and Soil Conservation have visited the property. He met with the adjoining owner, Bruce King, who was pleased with the final clean-up including silt fence, seeding and strawing of the slope. It was a bad situation. The attorney informed that soil run off is governed by York County Soil Conservation. Zoning Ordinance Section 397 Tree Removal in Environmentally Sensitive Areas was provided and will be forwarded to the Zoning Officer and York County Soil Conservation. The Zoning Officer will also be informed of other possible violations.

New Business

DCVFC – Fire Box Changes, Mike Smith, Chief, Delta-Cardiff Volunteer Fire Company. The Route 74 corridor will have a new box, Susquehanna Trails will be by addresses/road.

Hushon, Vincent & Bonnie – Map AO Parcel 31 - 795, 848, 862 Hushon Road. They propose to subdivide 795 Hushon Road with an acre of land from the remainder of the farm. The property owners presented the revised plans per the York County and Township Planning Commissions comments.

Metzler, Craig A & Jennifer K – Map BO Parcel 36, 933 Bryansville Road – 143.92 acres. The Land Development Plan includes 23,199 sqft. Poultry Barn, 8,525 sqft. Manure Storage, 3,600 sqft. Egg Room and associated Stormwater Management.

The applicants' engineer presented the plan with reviews from York County Planning Commission, York County Soil Conservation, DEP, and Township Planning Commission & Engineer. The existing driveway onto a PennDOT road is a non-issue. The submitted manure management plan shows they are not a CAO or CAFO since they have enough land mass. The plan still needs the NPDES Permit. Bills for engineering will be invoiced to the applicant.

- Ordinance No. 2024-01, Proposed Amendment to Zoning Ordinance and Zoning Map per Calpine, will be presented to the Planning Commission in July and the Board of Supervisors will hold a hearing at their August Meeting.
